Yoshimasa may at any time with or without notice refuse to permit further credit purchases.
2. Credit is to be extended at the sole discretion of Yoshimasa and upon such terms and conditions as Yoshimasa determines. Credit limitations set by Yoshimasa shall be for the protection of Yoshimasa and shall not be construed to be a limitation on the customer's or any guarantor's liability to Yoshimasa. Yoshimasa's delay or failure to enforce any such right or of any other rights shall not be deemed a waiver of any part of this agreement.
3. All goods and equipment sold will be due 30 days from date of invoice, or upon the agreement specified on the invoice. In the event that the account becomes delinquent, all invoices become immediately due and payable.
4. If the customer's account is referred for a collection, the customer shall pay all collection cost and attorney's fees and cost.
5. All monies received by Yoshimasa shall be applied to the outstanding obligation at Yoshimasa's discretion. If attorney's fees and cost have been incurred by Yoshimasa in the collection of any obligation, all monies received shall be first applied to the attorney's fees and cost.
6. Customer agrees to return the goods with the knowledge of pre-paid shipping and restocking charges of (15%) of the invoice to Yoshimasa in the event the purchase price is not paid to Yoshimasa in a timely manner.
